#### 1. APPROVAL OF MINUTES

#### February 27, 2017 Special Audit Committee Meeting Minutes

A motion was given by Warshaw and seconded by Grivich to approve the February 27, 2017 Special Audit Committee Minutes. Motion carried by a vote of 3-0-1 with Barnes abstaining and Spence absent.

#### 1. NOMINATION OF CHAIR

Committee Member Warshaw nominated Committee Member Grivich for the position of Chair. A motion was given by Warshaw and seconded by Grivich to appoint Committee Member Grivich as the next Chair of the Audit Committee. Motion carried by a vote of 3-1 with Rozatti in opposition and Spence absent.

#### 2. NOMINATION OF VICE-CHAIR

Committee Member Warshaw nominated Committee Member Barnes for the position of Vice-Chair. A motion was given by Warshaw and seconded by Grivich to appoint Committee Member Barnes as the next Vice-Chair of the Audit Committee. Motion carried by a vote of 4-0 with Spence absent.

Committee Member Grivich took over as Chair and asked if there were any oral comments. None were heard.

# 3. SINGLE AUDIT REPORT ON FEDERAL AWARDS FOR THE YEAR ENDED JUNE 30, 2016

A motion was made by Grivich and second by Rozatti to have the auditors review the Policy and Procedures for overtime salaries and being within budget. Motion carried 4-0 with Spence absent.
