5) Update of Sports Complex Office Space Available for City Use at Edgewood High School – Receive and file. – Presented by Superintendent Cresap

Superintendent Cresap reached out to Dave Larkin, West Covina Unified School District Project Manager, to confirm the item that was discussed at the previous Commission meeting on March 3, 2018, about the possible space/office at the Sports Complex at Edgewood High School for City and/or Sports Groups use. Superintendent Cresap was told that at this time, the plan does not include use of space by the City or Sports Groups within the City. Discussion was had. No action taken.

6) Update on the Shop Local After School Program – Receive and file. – Presented by Director Bresciani.

Update of the Shop Local After School Program was provided to the Commission to include, donations received from local businesses, the Districts that are receiving funding, how Districts are using those funds for the individual programs, as well as the City's involvement in the program. Discussion was had. No action was taken.

**8) Update Renaming of the Senior Center** – Receive and file. – Presented by Director Bresciani.

Update was given. Council did approve the Commission's recommendation to rename West Covina Senior Center to Cortez Community and Senior Center. Updating of signage on the exterior of the facility is in process. Use of CDBG funds will be available for the update/improvement of the reader board adjacent to the street. Staff is updating online and marketing materials currently. Discussion was had. No action taken.
