#### 1. Call to Order

#### 2. Previous Traffic Committee Items from the November 12, 2019 Traffic Committee Meeting

- i. Red Curb Installation at Stuart Avenue and Azusa Avenue for Increased Line of Sight
  - a. A resident submitted a request for the Traffic Committee to review line of sight conditions at Stuart Avenue and Azusa Avenue. A traffic study was presented on PowerPoint for the intersection which included a line of sight analysis per ASSHTO guidelines (American Association of Highway and Transportation Officials) as well as discussion of existing and proposed conditions. Based on the traffic analysis, the following recommendations were unanimously approved by the Traffic Committee members: (1) Repaint approximately 16-feet of existing red curb and add an additional 14-feet of red curb, for a total of 30-feet of red curb, to prohibit parking along the west side of Azusa Avenue just south of Stuart Avenue; and, (2) Install 55-feet of red curb to prohibit parking along the west side of Azusa Avenue just north of Stuart Avenue. Residents at northwest corner property will still have on street parking available along Stuart Avenue.
- ii. Red Curb Installation at Puente Avenue and Myrtlewood Avenue for Increased Line of Sight
  - a. A resident submitted a request for the Traffic Committee to review line of sight conditions at Puente Avenue and Myrtlewood Avenue. A traffic study was presented on PowerPoint for the intersection which included a line of sight analysis per ASSHTO guidelines (American Association of Highway and Transportation Officials) as well as discussion of existing and proposed conditions. Based on the traffic analysis, the following recommendations were unanimously approved by the Traffic Committee members: (1) Install 20-feet of red curb to prohibit parking along the north side of Puente Avenue just west of Myrtlewood Avenue; and, (2) Repaint the existing 50-feet of red curb along the north side of Puente Avenue just east of Myrtlewood Avenue.
- iii. Red Curb and Center Line Installation at the Turning Curve of Morris Avenue and Palm Drive for Increased Line of Sight
  - a. A resident submitted a request for the Traffic Committee to review the line of sight along the turning corner curve of Morris Avenue and Palm Drive. A traffic study was presented on PowerPoint for the intersection which included discussion of existing and proposed conditions. Based on the traffic analysis and the California Manual on Uniform Traffic Control Devices (CAMUTCD) Section 3B.01 about center line pavement markings, the following recommendations were unanimously approved by the Traffic Committee members: (1) Paint 20-feet of red curb on the south side of Palm Drive east of Morris Avenue, starting from curb return; and, (2) Paint the entire curb return in red as well to prohibit parking along the curb; and, (3) Install an approximately 80-foot long center line (approximately 23-foot lanes) consisting of a solid double yellow line along the center of the curve of the Morris Avenue and Palm Drive intersection to ensure vehicles are turning in their correct lane.
- iv. Red Curb Installation in Either Side of the Driveway Approach for 509 S Barranca Avenue
  - a. A resident submitted a request for the Traffic Committee to review installation of red curb on either side of their driveway approach at 509 S Barranca Avenue due to vehicles blocking or encroaching onto the

driveway entrance, making it difficult to pull in and out. After a thorough review of existing field conditions, the following recommendations were unanimously approved by the Traffic Committee members: (1) Paint 6-feet of red curb on both sides of the south driveway and 6-feet of red curb on the south side of the north driveway; and, (2) Repaint existing red curb on the north side of the north driveway; and (3) Work with West Covina's Police Department to do random enforcement during school hours.
