2. Previous Traffic Committee Items approved at the February 11, 2020 Traffic Committee Meeting

- i. **Traffic Review of Left Turn Access into Christ Lutheran School on Citrus Street:** A request was submitted to the City to review installation of a left turn pocket into the school's parking lot to improve street access into the parking lot as well as alleviate the queue in the NB travel lane. TC approved installation of a left turn pocket into the northern driveway with appropriate signage for entering and exiting vehicles to and from the school.
- ii. **Permit Parking Review on Oakridge Circle East between Temple Avenue to Cul-de-Sac:** A resident parking restriction application was submitted to the City for parking permits along this segment. TC approved the application for permit parking only along this street segment. Signs will be posted accordingly to designate the permit parking areas.
- iii. **Permit Parking Review on Mullender Street between Michelle Street to Francisquito Avenue:** A resident parking restriction application was submitted to the City for parking permits along this segment. TC approved the application for permit parking only along both sides of the street except in front of the Church where parking will be allowed at all times. Signs will be posted accordingly to designate the permit parking areas.
- iv. **KEEP CLEAR pavement markings and signage at Driveway to McIntyre Commercial Center on Citrus Street:** A business owner submitted a request for a KEEP CLEAR zone in front of one of their driveways on Citrus Street to allow patrons and emergency vehicles to access the shopping center. During peak commute hours vehicles are queuing waiting for the signal at Citrus Street and Garvey Avenue, with the queued vehicles blocking the driveway. TC approved the recommendation to install a KEEP CLEAR marking and signage in front of the driveway.
- v. **Announcement of the Upcoming Pacific Avenue Community Meeting:** No was action required, an announcement was given about the Community Meeting for the Baldwin Park Project proposed striping modifications on Pacific Avenue between Bromley Avenue and Ardilla Avenue in the City of West Covina. The Community Meeting was scheduled for February 24, 2020 at 6:00 PM.
