On March 4, 2020, Governor Newsom proclaimed a State of Emergency in California as a result of the threat of COVID-19. On March 17, 2020, Governor Newsom issued Executive Order N-29-20, suspending certain requirements of the Brown Act relating to the conduct of public meetings. Pursuant to the Executive Orders, Council Members may attend City Council meetings telephonically and the City Council is not required to make available a physical location from which members of the public may observe the meeting and offer public comment.

On June 18, 2020, the California Department of Public Health issued guidance mandating that people in California wear cloth face coverings in specified circumstances, including when they are inside, or in line to enter, any indoor public space.

All comments received will be made part of the official public record of the meeting.

**TELEPHONIC ACCESSIBILITY:** Members of the public that wish to address the Committee by telephone may do so by calling (714) 598-8896 by 12:00 noon on the day of the Committee meeting for instructions regarding addressing the Traffic Committee by telephone during the meeting.

#### 2. Previous Traffic Committee Items Approved at the previous Traffic Committee Meeting

- a) **Traffic Review of Left Turn Signage at the Intersection of Nogales Street and Amar Road:** The City of West Covina received a resident request to review the left turn signage for WB traffic located at the intersection of Nogales Street and Amar Road. There are currently two left turning lanes for westbound travel along Amar Road. The existing signage mounted onto the mast arm at this intersection is recommended to be updated to reflect the new left turn lane. The Traffic Committee unanimously approved and recommended that an updated sign be installed on the mast arm located at the intersection of Nogales Street and Amar Road to match the existing left turn lane conditions for westbound travel along Amar Road. The existing sign should be removed and replaced accordingly. This item will go before City Council for final approval.
- b) **Review of Street Sweeping Signage Along Sentous Avenue between Valley Boulevard and Valley View Avenue:** The City of West Covina received a request to install street sweeping signage along the east side of Sentous Avenue between Valley Boulevard and Valley View Avenue. Due to the lack of street sweeping signage, Sentous Avenue is not able to be regularly swept due to vehicles being parked along the curb for long periods of time causing the curb line and sidewalks to accumulate trash. The Traffic Committee unanimously approved and recommended to install and post “No Parking 2nd & 4th Fridays of the Month” Signs, per the City of West Covina Residential Street Sweeping Route Map. This item will go before City Council for final approval.
