This memorandum presents the findings of a cultural resources study completed in support of the 1024 West Workman Avenue Residential Project, a proposed infill, residential development located at 1024 West Workman Avenue in West Covina, California (project). Rincon Consultants, Inc. (Rincon) was retained by MLC Holdings, Inc. to support the project's compliance with the California Environmental Quality Act (CEQA). This memorandum documents the results of the tasks performed by Rincon, specifically a cultural resources records search, Sacred Lands File Search, archival and background research, and an intensive-level field survey. All work was completed in accordance with CEQA and applicable local regulations.

This study was prepared by cultural resources specialist Alexandra Madsen, MA, RPA, who meets the Secretary of the Interior's Professional Qualification Standards (PQS) for history, architectural history, and archaeology. Additional support was provided by architectural historians James Williams, MA and Steven Treffers, MHP, with quality assurance/quality control completed by Rincon Principal Christopher Duran, MA, RPA, each of whom meets the PQS in their respective fields.

Project Description

The project site is located at 1024 West Workman Avenue, West Covina, Los Angeles County, California and includes Assessor's Parcel Number (APN) 8457-029-906 (Attachment A, Figure 1). The project site is developed with the former Vincent School public elementary school campus, which is currently used as a childcare center. The project site is surrounded by residential development, with Interstate 10 located approximately 375 feet to the south (Attachment A, Figure 2). The project involves the demolition of existing buildings and the construction of 120 homes: 51 single family detached single-family residences and 69 attached townhomes (Attachment A, Figure 3).



Methods

Cultural Resources Records Search

A search of the California Historical Resources Information System (CHRIS) at the South Central Coastal Information Center (SCCIC) located at California State University, Fullerton was requested on August 25, 2020 and received by Rincon on October 15, 2020. The search was performed to identify all previously recorded cultural resources, as well as previously conducted cultural resources studies within the project site and a 0.5-mile radius surrounding it.

The SCCIC records search included a review of the listings of the NRHP, the CRHR, California Points of Historical Interest, California Historical Landmarks, and the California Built Environment Resources Directory (BERD). This search confirmed there are no NRHP or CRHR listed properties, California Points of Historical Interest or Historical Landmarks, or BERD-listed resources located within or adjacent to the project site.

The SCCIC records search identified eight previously conducted studies within a 0.5-mile radius of the project site, none of which intersect the project site (Table 1). A summary of these studies included with the records search is included in Attachment B.

The SCCIC records search identified 12 previously recorded cultural resources within a 0.5-mile radius of the project site, all of which were built environment resources. None of these were eligible historical resources or located within the project site. A summary of the previously recorded resources can be seen in Table 2 below.

Archival and Background Research

Archival research was completed in September through December 2020 and focused on the review of a variety of primary and secondary source materials relating to the history and development of the project site and its surroundings. Sources included, but were not limited to, historic maps and aerial photographs, contemporary newspaper articles, and written histories of the area. The following is a list of sources consulted in order to conduct research pertaining to the subject property.

- City of West Covina Historic Survey Report and Citywide Context Statement (2006)
- City of West Covina Historic Context Statement and Historic Resource Inventory Update (2019)
- Additional sources as indicated in the References section

Review of Historical Topographic Maps and Aerial Imagery

Rincon reviewed available historical maps and aerial imagery to assess past land use of the project site. Available aerial imagery from 1948 shows the area improved with trees and several single-family homes. Adjacent land uses were agricultural, and citrus trees were located on the parcel immediately to the west. Between 1952 and 1953, the trees from the parcel were cleared and some of the single-family residences appear to have been demolished. By 1964, the subject property was improved with the Vincent School and surrounding parcels were developed with single-family tract homes. U.S. Highway 101 was also constructed by this date and is visible in aerials to the south (NETR 1948, 1952, 1953, 1964; Google Earth, various).



City of West Covina Survey Report and Citywide Historic Context Statement (2006)

In 2006, Historic Preservation Partners completed *Survey Report and Citywide Historic Context Statement* on behalf of the City of West Covina. In addition to summarizing major themes in the community's history between the late eighteenth century and the mid-twentieth century, the report documents a survey of historic properties constructed in the city prior to 1946. The survey was conducted in three phases and covered the entirety of West Covina's city limits. Following an initial windshield survey of the city documented around 300 residences, recording each on DPR 523 forms. In the second phase, a more in-depth reconnaissance survey recorded properties that had not incurred substantial alteration. Finally, in the third phase, an intensive-level survey documented 89 properties deemed most likely to be individually eligible for designation and recorded them on full sets of DRP 523 forms. Of the 89 documented properties, 33 of these properties were "recommended for immediate protection."

City of West Covina Historic Context Statement and Historic Resource Inventory Update (2019)

Between 2018 and 2019 and on behalf of the City of West Covina, Galvin Preservation Associates (GPA) Consulting completed the *City of West Covina Historic Context Statement, 1945-1978, and Historic Resource Inventory Update.* To update the City's existing historic context statement, the project reviewed properties previously identified as historically significant and identified properties constructed throughout the city between 1945 and 1978 that have historical significance.

In addition to expanding upon the existing historic context statement, GPA conducted a reconnaissance-level survey of the city and identified 90 properties that merited further investigation. Using the themes of the updated historic context statement, these properties were researched and evaluated for listing in the National Register of Historic Places (NRHP), California Register of Historical Resources (CRHR), and for City of West Covina landmark or historic district status. Evaluations were documented on California DPR 523 forms.

Previous Evaluation of Vincent School

The former Vincent School, which comprises the project site, was evaluated in 2019 as part of the *City of West Covina Historic Context Statement, 1945-1978, and Historic Resource Inventory Update* (2019) by Amanda Duane of GPA. The property was found to be typical of a public elementary school dating from the mid-twentieth century. On this basis the property was recommended ineligible for listing in the NRHP and CRHR and for designation as a City of West Covina Landmark. The evaluation of Vincent School is included as Attachment D.

Native American Scoping

As part of the process of identifying cultural resources for this project, Rincon contacted the Native American Heritage Commission (NAHC) on September 23, 2020 and requested a Sacred Lands File (SLF) search and a list of Native American tribal organizations and individuals who may have knowledge of sensitive cultural resources in or near the project site.



On October 2, 2020, Rincon received a response from the NAHC stating the SLF search results were negative for site-specific information. Attachment C provides documentation of communication with the NAHC and results of the SLF.

Pedestrian Field Survey

Ms. Alexandra Madsen, MA, RPA conducted a pedestrian field survey of the project site on January 5, 2021 (Attachment A, Figure 4). Areas of exposed ground were inspected for prehistoric artifacts (e.g., flaked stone tools, tool-making debris, stone milling tools, ceramics, fire-affected rock), ecofacts (marine shell and bone), soil discoloration that might indicate the presence of a cultural midden, soil depressions, and features indicative of the former presence of structures or buildings (e.g., standing exterior walls, postholes, foundations) or historic debris (e.g., metal, glass, ceramics).

Ground disturbances such as burrows and drainages were also visually inspected. Results of the field survey identified no evidence of archaeological remains or historic built-environment resources within the project site. Ground visibility throughout the project site was very poor (approximately less than 10 percent) due to vegetation including grass and weeds (Attachment A, Figure 5).

Approximately half of the project site is highly disturbed due to past development. Modern disturbances on the project site include modern refuse along the eastern boundary. No archaeological resources were identified within the project site.

Findings and Recommendations

As discussed above, one property within the project site was previously recorded and evaluated by GPA on behalf of the City of West Covina in 2019, the Vincent School at 1024 Workman Avenue. The property was found ineligible for federal, state, and local designation. Therefore, the City, which is serving as the lead agency for the current project, has determined the property is not considered a historical resource under CEQA and its demolition would not result in a significant impact.

The CHRIS records search did not identify any archaeological resources in or adjacent to the project area, and the SLF search results were negative for any known resources located within or near the project site. The pedestrian field survey also did not identify any archaeological resources within the project site. The results of this study therefore indicate the project site exhibits a low sensitivity for containing intact, subsurface archaeological deposits.

Based on these findings, Rincon recommends a finding of **no impact to historical resources** and **less than significant impact with mitigation for archaeological resources** under CEQA.

Rincon presents the following measures in case of unanticipated discovery of cultural resources during project development. The project is also required to adhere to regulations regarding the unanticipated discovery of human remains, detailed below.

Unanticipated Discovery of Archaeological Resources

If archaeological resources are encountered during ground-disturbing activities, work in the immediate area should be halted and an archaeologist meeting the Secretary of the Interior's Professional Qualification Standards for archaeology (National Park Service 1983) should be contacted immediately to evaluate the find. If necessary, the evaluation may require preparation of a treatment plan and



archaeological testing for CRHR eligibility. If the discovery proves to be significant under CEQA and cannot be avoided by the project, additional work, such as data recovery excavation, may be warranted to mitigate any significant impacts to historical resources.

Unanticipated Discovery of Human Remains

The discovery of human remains is always a possibility during ground-disturbing activities. If human remains are found, the State of California Health and Safety Code Section 7050.5 states that no further disturbance shall occur until the County Coroner has made a determination of origin and disposition pursuant to Public Resources Code Section 5097.98. In the event of an unanticipated discovery of human remains, the County Coroner must be notified immediately. If the human remains are determined to be prehistoric, the Coroner will notify the Native American Heritage Commission, which will determine and notify a most likely descendant (MLD). The MLD shall complete the inspection of the site and provide recommendations for treatment to the landowner within 48 hours of being granted access.




Figure 2 Project Site

B10. Significance (Continued from Page 2): The Vincent School was constructed c. 1960 as an elementary school campus. Today, it is used for special education and childcare programs provided by the school district. Research indicates that the construction of the campus was merely part of an ongoing trend of postwar school construction. Research did not reveal any evidence that the campus has an association with an important individual event. Mere association with a trend, in this case the need for school construction to meet a growing population is not sufficient for significance under National Register (NR) and California Register (CR) Criterion A/1 nor West Covina Landmark Criterion A. The association must also be significant. Therefore, it does not appear to be eligible under Criterion A/1/A.

Research did not reveal an association with specific individuals that might be significant to the history of West Covina. While numerous people have worked at the Vincent School since its construction, collaborative efforts like these are better evaluated under Criterion A/1/A. Therefore, the campus does not appear to be eligible under Criterion B/2/B.

The campus possesses characteristics of the Mid-Century Modern style, but it is a typical example of postwar school construction conducted on a large scale using similar stylistic features and materials throughout the region. The commonly seen combination of design details and materials of this campus does not exemplify the distinctive characteristics of a type, period, or method of construction, because it is not an important example of building practices from a particular time in history. Schools of similar design and form are extant throughout Southern California and research did not reveal any reason to suggest that this campus had an impact on this type of construction, nor does it represent an evolution or transition. Research did not reveal the school's architect; however, it is more likely that it was designed by an architect or architects hired by the school district to design a number of campuses rather than representing the work of a master. Therefore, the campus is not significant under West Covina Criterion D as representative of the notable work of a builder, designer or architect. Lastly, the campus does not represent a historic district. To be eligible under this component of Criterion C/3, a property must also be significant under Criterion A/1, B/2, and/or another portion of Criterion C/3. That does not apply in this instance; therefore, the campus does not appear to be eligible under Criterion C/3.

NR and CR Criterion D/4 generally applies to archaeological resources, but may apply to a built resource in instances where a property may contain important information about such topics as construction techniques or human activity. In any case, the property must be the principal source of information. This is unlikely to be true for the former elementary school campus. Therefore, it does not appear to be eligible under Criterion D/4.

Lastly, the Vincent School campus does not appear to meet West Covina Criterion E. The campus does not appear to have a unique location or physical characteristic(s) or represent an established and familiar visual feature or landmark of a neighborhood, community, or the city.

The property does not have historic significance; therefore, a discussion of its integrity, or its ability to convey significance, is not necessary.
