Halt to City of West Covina Administered Public Health Department

To the Honorable City Council of The City of West Covina: We, the undersigned registered voters of The City of West Covina, California, by this petition hereby respectfully propose the following legislative act be adopted by the City Council or submitted to the registered voters of The City of West Covina for their adoption or rejection:

AN ORDINANCE OF THE CITY OF WEST COVINA TO HALT THE CITY ADMINSTERED PUBLIC HEALTH DEPARTMENT MAY 18 PM

WHEREAS, the City of West Covina already contributes to Los Angeles County expenses, including those related to the County Health Department through property taxes which currently provide public health department and officer duties.

WHEREAS, the City of West Covina City Council recently passed ordinances and resolutions regarding the termination of agreements with the County of Los Angeles regarding health officer and public health duties.

WHEREAS, the City of West Covina City Council passed ordinances and resolutions regarding the creation of a local health department and hiring of a local health officer.

WHEREAS, the City of West Covina already has significant general fund expenditures in the funding of police, fire, employee pensions and other municipal services and the California State Auditor concluded in December 2020 "that West Covina is a high risk city because of the significant risks it faces related to its financial and operational management."

WHEREAS, the City of West Covina has spent city staff time resources to prepare the abovementioned ordinances and will incur significant additional expenses to implement its own local health department with city staff or through personal service contracts.

WHEREAS, the City of West Covina is unlikely to recoup any property tax monies already paid to the county in order to recoup funding for city administered public health effort.

WHEREAS, West Covina voters and residents were not surveyed or consulted regarding the City of West Covina establishing its own public health effort.

NOW THEREFORE, the People of the City of West Covina does ordain as follows:

Section 1. <u>TITLE</u>. This ordinance shall be known as the City of West Covina Halt to City Administered Public Health Department Ordinance. This ordinance would rescind all prior City Council ordinances and resolutions regarding discontinuing public health services with the County of Los Angeles and the establishing of a city administered local public health department or effort.

Section 2. <u>OPERATIVE DATE.</u> "Operative Date" will be 30 days after the adoption of this ordinance.

Section 3. <u>PURPOSE</u>. This ordinance is adopted to rescind any and all efforts taken to have West Covina establish its own public health department in order to preserve and enhance general municipal services with all available funds including any additional Federal or State monies issued to the City and to prevent city residents from paying any additional expenses for health department services that are already being provided by the County, including, but not limited to, among other purposes, and directs that the provisions hereof be interpreted to accomplish those purposes:

- A. That all prior City resolutions and ordinances regarding the termination of Los Angeles County Health Officer Services and establishing of a local health department be rescinded by the operative date specified in this ordinance above. Specifically this would include but not be limited to the following resolutions and ordinances:
 - a.
